Secretary's 2013 Annual Report

The Secretary continued to handle inquiries regarding membership benefits, subscriptions to the International Journal of Legal Information and questions about the IALL website throughout the year. The Secretary also served as Chair of the Scholarships Committee, coordinated the scholarship application and selection process, and answered questions regarding the scholarship application process as well as inquiries regarding the 2013 conference.
